## Feed Your Immune System with Soup Sweepstakes

- 1. Eligibility: The Mushroom Council's (MC) "Feed Your Immune System with Soup" Sweepstakes (the "Sweepstakes") is open to those who are 18 years old, or the age of majority in their state of residence, whichever is older, as of the date of entry. 3. Tag your a friend who also loves mushroom soup in the comments of the Instagram post from @mushroomcouncil on 3/1/23.

The Entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize.
