



**2026 National Mushroom Month:
Ultimate Grilling Sweepstakes
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: The Mushroom Council's (MC) "2026 National Mushroom Month: Ultimate Grilling Sweepstakes" (the "Sweepstakes") is open to those who are 18 years old, or the age of majority in their state of residence, whichever is older, as of the date of entry. The Sweepstakes is only open to legal residents of the United States and is void where prohibited by law. Employees of the Mushroom Council (MC) (the "Sponsor") and their respective parent, affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes.
